



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Peter Collis, the appellant(s), by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,125
IMPR.: \$28,267
TOTAL: \$33,392

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 5,000 square foot parcel of land improved with a 59-year-old, two-story, frame and masonry, multi-family dwelling, containing 2,300 square feet of living area. The property is located in Riverside, Riverside Township, Cook County and is a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of its overvaluation argument, the appellant submitted sales information on three comparable sales properties that sold between May of 2021 and July of 2022 for prices ranging between \$58.10 to \$144.56 per square foot of living area, including land. Each of the comparable sales was improved with either a one-story or a two-story multi-family dwelling of either frame or masonry construction. They ranged from 2,074 to 3,804 square feet of living area and from 61 to 136 years of age. The petition discloses the subject is not an owner-occupied residence. The appellant also included a

copy of the board of review's written decision reflecting a final assessment for the subject property of \$33,392. Based on this evidence, the appellant requested a reduction in the subject's assessment to \$25,703.

The board of review submitted its "Board of Review Notes on Appeal" depicting a total assessed valuation of \$33,392, with an improvement assessment of \$28,267, or \$12.29 per square foot of living area. The subject's assessment reflects a market value of \$333,920, or \$145.18 per square foot of living area when applying the level of assessment for class 2 property of 10.00% under the Cook County Real Property Assessment Classification Ordinance.

In support of its contention of the correct assessment, the board of review submitted information on four comparable sales properties. Each of the comparable properties were improved with either a one-story or a two-story, multi-family dwelling, of either masonry, frame and masonry, or stucco construction. They ranged in size between 1,913 and 2,680 square feet of living area and in age between 59 and 105 years old. The board of review's comparables sold between November of 2021 and November of 2022 for prices ranging from \$156.72 and \$201.25 per square foot of living area, including land.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of market value to be appellant's sales comparable #1 and the board of review's sales comparables #2 and #3. These properties sold between May of 2021 and August of 2022 for prices ranging between \$144.56 to \$182.82 per square foot of living area, including land. The best comparables were most similar to the subject property in living area square footage. The subject's current assessment of \$145.18 per square foot of living area, including land, reflects a market value within the market value established by the best comparables in this record. Based on this record, the Board finds the appellant has not proven, by a preponderance of the evidence, that the subject is overvalued, and that a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
