



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Robert Ipsen, the appellant(s), by attorney Jeremy Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$18,841
IMPR.: \$64,408
TOTAL: \$83,249

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story structure of frame construction, approximately ninety-six years-old, with 4,134 square feet of living area. The property is on an 18,841 square foot site in Mount Prospect, Elk Grove Township, Cook County. The subject is classified as 2-06 under the Cook County Real Property Assessment Classification Ordinance. Features of the building include four full bathrooms, one half bathroom, a partial basement, air conditioning and a two-and-a-half-car garage.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables with varying degrees of similarity to the subject property. The properties offered by the appellant are two-or-more-story class 2-34 houses of frame and masonry or frame construction, ranging in age from sixty-nine to ninety-four years-old and ranging in size from 3,452 to 3,613 square feet of living area.

Two comparables have three full bathrooms and one half bathroom, one has two full and two half bathrooms and one has three full bathrooms. Three of the comparables have a full basement and one has a partial basement. All have air conditioning and a two-car garage. They range in distance to the subject property from 0.1 to 0.4 miles. Based on this evidence, the appellant is requesting an assessment amount of \$75,105.

The board of review submitted its “Board of Review Notes on Appeal” stating the total assessment for the subject property as \$83,249 including an improvement assessment of \$64,408 or \$15.58 per square foot.

In support of its contention of the correct assessment, the board of review submitted information on three equity comparables. The properties offered by the board of review are two-story buildings: one of frame, one of masonry and one of frame and masonry construction. They range in age from sixty-nine to eighty-nine years old and range in size from 3,451 to 3,654 square feet of living area. The comparables range in the number of full bathrooms from two to four. All have a half bathroom, a full basement and air conditioning. Two have a two-car garage and one has a two-and-a-half car garage. The board of review reports that its comparable #2 is located a quarter-mile from the subject property. No information is given on the distance of the other two comparables to the subject.

Conclusion of Law

The taxpayer asserts assessment inequity as the basis of the appeal. The Illinois Constitution requires that real estate taxes, “be levied uniformly by valuation ascertained as the General Assembly shall provide by law.” Ill. Const. art. IX, §4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). This uniformity provision of the Illinois Constitution does not require absolute equality in taxation, however, and it is sufficient if the taxing authority achieves a reasonable degree of uniformity. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4th Dist. 2003).

When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by the appellant by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e); Walsh, 181 Ill. 2d at 234 (1998). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof needed for a conviction of a crime. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity, and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant **did not** meet this burden of proof and a reduction in the subject's assessment **is not** warranted.

The Board finds the best evidence of assessment equity to be the appellant's comparable #1 and the board of review's comparables #2 and #3. These properties are similar to the subject in terms of living area, age, construction and, with the exception of the board of reviews comparable #3, proximity. In contrast, the appellant's comparables #2, #3 and #4 and the board of review's comparable #1, are all at least 650 square feet smaller than the subject property in living area.

The Board finds that these comparables are afforded less weight based on these factors. The best evidence comparables have improved assessed values ranging from \$13.01 to \$17.69 per square foot. The subject property's improvement assessment of \$15.58 per square foot falls within the range established by the best comparables in the record. Based on this record the Board finds the appellant **did not** demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment *is not* justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
