



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board (PTAB) are Edgardo Diaz, the appellant, by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, PTAB hereby finds **No Change** in the Cook County Board of Review's assessment of the property is warranted. The correct assessed valuation of the property is:

LAND: \$5,500
IMPR.: \$22,999
TOTAL: \$28,499

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a Cook County Board of Review decision pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 1,288 square feet, one-story brick building on a 5,500 square feet lot in Riverside of Riverside Township, Cook County. The 72-year-old home, a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance, included one bathroom, a full basement, air conditioning, and a two-car garage.

The appellant contends the subject assessment overvalues the subject property based on recent sales of comparable properties. To demonstrate the \$28,499 assessment exaggerates the subject's market value, the appellant presented four sales of stucco or frame buildings within .38 miles of the subject. The properties in evidence ranged from 96 to 103 years in building age and contained 1,000 to 1,554 square feet in living area; one or 1.5 bathrooms; and a one- to 2.5-car garage. The appellant's selected sales occurred between August 2021 and December 2022 for \$170,000 to \$300,000, or \$144.56 to \$199.90 per square foot.

The county board of review responded in its “Notes on Appeal” that the subject was correctly assessed at \$28,499. The subject’s assessment reflects a market value of \$284,990, or \$221.27 per square foot, when applying the 10% Cook County assessment level for class two properties. In defense of the assessment, the board of review submitted four sales between July 2020 and May 2023 with purchase prices from \$276,000 to \$407,500, or \$244.68 to \$301.18 per living square foot. The involved properties all had air conditioning, a full basement, and between 1,065 and 1,353 square feet of improvement area.

Conclusion of Law

The appellant contends the subject assessment overvalues the property. When market value is the basis of the appeal, the value of the property must be proven by a preponderance of the evidence. 86 Ill. Admin. Code §1910.63(e); Winnebago County Bd. of Review v. Property Tax Appeal Bd., 313 Ill. App. 3d 1038, 1043 (2d Dist. 2000). Proof of market value may consist of a recent sale or appraisal of the subject property, comparable sales, or construction costs. 86 Ill.Admin.Code §1910.65(c). The Property Tax Appeal Board (PTAB) finds the appellant failed to satisfy this burden of proof.

In this record, the best evidence of market value resides in board of review comparable sales #1, #2, and #4. The properties in these board of review sales approximate the subject’s value because the improvements were similar to the subject in living area, garage size, air conditioning inclusion, and basement type. By contrast, the appellant’s sales all involved improvements that differed greatly from the subject improvement’s building age or size. Based on these sales, the subject’s 2023 market value was likely between \$244.68 and \$301.18 per square foot. Because the subject’s implied market value of \$284,990, or \$221.27 per square foot, falls below the market value indicated by the evidence, PTAB finds the appellant did not prove the subject assessment exaggerated the property’s market value by a preponderance of the evidence and an assessment reduction is accordingly not merited.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
