



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Kamila English

The parties of record before the Property Tax Appeal Board are Kamila English, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook, and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$7,500
IMPR.: \$35,520
TOTAL: \$43,020

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame exterior construction with 2,400 square feet of living area. The dwelling is approximately 3 years old.¹ Features of the home include a full basement, central air conditioning, 3½ bathrooms, a fireplace, and a two-car garage. The property has a 3,750 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

¹ The subject property was also presented in Docket No. 22-37719 in which the parties agreed the dwelling was 3 years old. In this 2023 tax year appeal, the board of review reported the dwelling is 2 years old while the appellant reported the home is now 4 years old. The Board finds the best description is that the dwelling is approximately 3 years old.

The appellant contends assessment inequity concerning the improvement as the basis of the appeal. In support of the inequity argument, the appellant submitted information on four equity comparables located in the same neighborhood code as the subject and .7 of a mile to 1.2-miles from the subject. The comparables consist of class 2-78 two-story dwellings of frame or frame and masonry exterior construction and which are 19 to 21 years old. The comparables range in size from 2,268 to 2,708 square feet of living area. The comparables have full or partial basements, central air conditioning, 2½ or 3 bathrooms, and three comparables each have a two-car garage. One comparable has a fireplace. The comparables have improvement assessments ranging from \$28,560 to \$34,626 or from \$12.67 to \$13.03 per square foot of living area.

Based on this evidence, the appellant requested a reduced improvement assessment of \$30,888 or \$12.87 per square foot of living area reflecting the average of the comparables presented.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$43,020. The subject property has an improvement assessment of \$35,520 or \$14.80 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on three equity comparables located in the same neighborhood code and same block, subarea, or ¼ of a mile from the subject. The comparables consist of one class 2-02 one-story and two class 2-78 two-story dwellings of frame or masonry exterior construction that are 1 to 67 years old. The homes range in size from 911 to 2,386 square feet of living area. Features include full basements, central air conditioning, 1 or 3½ bathrooms, and a 1.5-car or a 2-car garage. Two homes each have a fireplace. The comparables have improvement assessments ranging from \$16,500 to \$47,911 or from \$16.40 to \$20.08 per square foot of living area.

Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven equity comparables to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to the appellant's comparables #1, #2 and #4 as well as board of review comparable #2, due to substantially older dwellings, differing basement size, differing dwelling sizes, and/or lack of a garage when compared to the subject.

On this limited record, the Board finds the best evidence of assessment equity to be appellant's comparable #3 along with board of review comparables #1 and #3, despite two of these homes

being 19 years old. These three homes have the same classification, neighborhood code, story height, somewhat similar dwelling sizes, and foundation types to the subject. In addition, these comparables are closer in age to the subject dwelling than the other comparables in the record. These homes are also similar to the subject in air conditioning, and garage capacity. Adjustments to the comparables are necessary for the difference in bathroom count, dwelling size, fireplace, and/or age when compared to the subject. These best comparables have improvement assessments ranging from \$33,840 to \$47,911 or from \$12.97 to \$20.08 per square foot of living area. The subject's improvement assessment of \$35,520 or \$14.80 per square foot of living area is within the range of the best comparables in this record both in terms of overall improvement assessment and on a per-square-foot of living area basis.

The constitutional provision for uniformity of taxation and valuation does not require mathematical equality. The requirement is satisfied if the intent is evident to adjust the taxation burden with a reasonable degree of uniformity and if such is the effect of the statute enacted by the General Assembly establishing the method of assessing real property in its general operation. A practical uniformity, rather than an absolute one, is the test. Apex Motor Fuel Co. v. Barrett, 20 Ill. 2d 395 (1960). Although the comparables presented by the parties disclosed that properties located in the same area are not assessed at identical levels, all that the constitution requires is a practical uniformity which appears to exist on the basis of the evidence.

Based on this record and after considering appropriate adjustments to the best comparables in the record for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
