



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Arthur Wicklund, the appellant, by attorney Dora Cornelio, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$46,875
IMPR.: \$49,585
TOTAL: \$96,460

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Property Tax Appeal Board pursuant to section 16-185 of the Property Tax Code (35 ILCS 200/16-185) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 3-story building of masonry exterior construction with 3,564 square feet of building area. The building is approximately 117 years old. The building features a full basement, central air conditioning and a 2-car garage. The property has a 3,125 square foot site and is located in Chicago, Lake View Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five equity comparables located within the subject's neighborhood code. The comparables are improved with class 2-11, 2-story or 3-story buildings of frame or masonry exterior construction that range in size from 2,450 to 3,908 square feet of building area. The buildings range in age from 112 to 141 years old. Each comparable has a basement. Two comparables each have central air

conditioning and one comparable has a 2-car garage. The comparables have improvement assessments that range from \$18,386 to \$38,625 or from \$7.50 to \$9.88 per square foot of building area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$33,394 or \$9.37 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$117,086. The subject property has an improvement assessment of \$70,211 or \$19.70 per square foot of building area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables located within the subject's neighborhood code. The comparables are improved with class 2-11, 3-story buildings of masonry exterior construction that range in size from 3,624 to 4,077 square feet of building area. The buildings range in age from 117 to 128 years old. Each comparable has a full basement. One comparable has central air conditioning and three comparables each have a 2-car garage. The comparables have improvement assessments that range from \$48,417 to \$58,125 or \$13.36 and \$14.56 per square foot of building area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds a reduction in the subject's assessment is warranted based upon the evidence in the record.

The parties submitted nine assessment comparables to support their respective positions before the Property Tax Appeal Board. The Board has given less weight to appellant's comparables #1, #2, #3 and #5 due to their older ages and their dissimilar story height when compared to the subject.

The Board finds the best evidence of assessment equity to be appellant's comparable #4 along with the board of review comparables. These properties are all relatively similar to the subject in location, dwelling size, design and age. These most similar comparables have improvement assessments ranging from \$38,048 to \$58,125 or from \$9.87 to \$14.56 per square foot of building area. The subject's improvement assessment of \$70,211 or \$19.70 per square foot of building area falls above the range established by the best comparables in this record. Based on this record, the Board finds the evidence demonstrates the subject's improvement is inequitably assessed by clear and convincing evidence and a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
