



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: O Oluarez

The parties of record before the Property Tax Appeal Board are O Oluarez, the appellant, by attorney Andrew S. Dziuk, of Andrew Dziuk, Esq. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **A Reduction** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$10,329
IMPR.: \$17,340
TOTAL: \$27,669

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Property Tax Appeal Board pursuant to section 16-185 of the Property Tax Code (35 ILCS 200/16-185) challenging the assessment for the 2023 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a 1.5-story dwelling of frame exterior construction containing 1,700 square feet of living area. The dwelling is approximately 94 years old. Features include a full basement with finished area, central air conditioning, and a 2-car garage. The property has a 3,689 square foot site located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends the assessment of the subject property as established by the decision of the Property Tax Appeal Board for the 2022 tax year should be carried forward to the 2023 tax year pursuant to section 16-185 of the Property Tax Code. (35 ILCS 200/16-185). The appellant disclosed that the subject property is an owner-occupied residence that was the subject matter of an appeal before the Property Tax Appeal Board in the prior year under Docket Number 22-46154. In that appeal, the Property Tax Appeal Board issued a decision lowering the assessment

of the subject property to \$27,669 based on the evidence in the record. Based on this evidence, the appellant requests that the Property Tax Appeal Board “carry forward” the 2022 tax year decision to the 2023 tax year.

The board of review submitted its "Board of Review Notes on Appeal." The board of review disclosed that 2021 was the beginning of the general assessment period for the subject property and that no township equalization factor was applied in 2023 by county assessment officials. The board of review did not challenge the appellant’s assertion that the subject property is an owner-occupied dwelling. The board of review did not submit any comparable properties in support of its contention of the correct assessment. However, the board of review asserted that the subject property sold in 2021 and the rollover should be denied. The board of review’s evidence included documentation in support of the subject’s 2021 sale, as well as noting the sale in its grid analysis.

Conclusion of Law

The appellant raised a contention of law asserting that the assessment of the subject property as established by the Property Tax Appeal Board for the 2022 tax year should be carried forward to the 2023 tax year pursuant to section 16-185 of the Property Tax Code. (35 ILCS 200/16-185). When a contention of law is raised the burden of proof is a preponderance of the evidence. (See 5 ILCS 100/10-15). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds that the assessment as established by the Property Tax Appeal Board for the 2022 tax year should be carried forward to the 2023 tax year at issue subject only to equalization, if any, as provided by section 16-185 of the Property Tax Code.

Section 16-185 of the Property Tax Code (35 ILCS 200/16-185) states in part:

If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel on which a residence occupied by the owner is situated, such reduced assessment, subject to equalization, shall remain in effect for the remainder of the general assessment period as provided in Sections 9-215 through 9-225, ***unless that parcel is subsequently sold in an arm's length transaction establishing a fair cash value for the parcel that is different from the fair cash value on which the Board's assessment is based***, or unless the decision of the Property Tax Appeal Board is reversed or modified upon review. (emphasis added)

The record disclosed the Property Tax Appeal Board issued a decision reducing the subject's assessment for the 2022 tax year under Docket Number 22-46514 to \$27,669 based on the evidence in this record. The record further indicates that the subject property is an owner-occupied dwelling and that 2022 and 2023 are within the same general assessment period for Jefferson Township. The record contains no evidence indicating the subject property sold in an arm's length transaction after the Property Tax Appeal Board's decision or that the decision of the Property Tax Appeal Board has been reversed or modified upon review. However, the Board did find the 2021 sale, reported by the board of review, occurred prior to the 2022 tax year decision.

The record also disclosed that a township equalization factor was not applied in the 2023 tax year by county assessment officials. For these reasons the Property Tax Appeal Board finds that a reduction in the subject's assessment is warranted to reflect the assessment as established in the Board's prior 2022 tax year decision.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
