



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Shelley Clark
DOCKET NO.: 24-00625.001-R-1

The parties of record before the Property Tax Appeal Board are Shelley Clark, the appellant, by attorney Andrew J. Rukavina, of The Tax Appeal Company in Mundelein; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$61,655
IMPR.: \$120,706
TOTAL: \$182,361

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 1-story dwelling of wood siding exterior construction with 1,712 square feet of living area. The dwelling was constructed in 1970 and is approximately 54 years old. Features of the home include a basement with finished area, central air conditioning, two fireplaces, and a 462 square foot garage. The property has an approximately 18,090 square foot site and is located in Mundelein, Fremont Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales located within 0.56 of a mile from the subject. The parcels range in size from 9,560 to 23,000 square feet of land area and are improved with 1-story homes of wood siding exterior construction ranging in size from 1,237 to 2,368 square feet of living area. The dwellings were built from 1955 to 1964. Each home has a basement with finished area, one of which is a walkout, central air conditioning, and a garage

ranging in size from 336 to 624 square feet of building area. Three homes have a fireplace. The comparables sold from April to August 2023 for prices ranging from \$328,500 to \$667,000 or from \$265.56 to \$305.32 per square foot of living area, including land.

Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$182,361. The subject's assessment reflects a market value of \$547,138 or \$319.59 per square foot of living area, land included, when using the statutory level of assessment of 33.33%.¹

In support of its contention of the correct assessment the board of review submitted information on four comparable sales. Comparable #4 is the same sale as the appellant's comparable #3. The parcels range in size from 10,820 to 20,720 square feet of land area and are improved with 1-story homes of brick or wood siding exterior construction ranging in size from 1,428 to 2,220 square feet of living area. The dwellings range in age from 39 to 64 years old. Each home has a basement with finished area, central air conditioning, one or two fireplaces, and a garage ranging in size from 418 to 624 square feet of building area. The comparables sold from January to November 2023 for prices ranging from \$470,000 to \$757,500 or from \$292.79 to \$426.52 per square foot of living area, including land.

The board of review submitted a copy of a Real Estate Transfer Declaration for the appellant's comparable #1 indicating it was not advertised for sale. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains a total of seven comparable sales, with one common sale, for the Board's consideration. The Board gives less weight to the appellant's comparables and the board of review's comparables #3 and #4, due to substantial differences from the subject in dwelling size. Moreover, the appellant's comparable #1 was not advertised for sale, suggesting this was not an arm's length sale indicative of market value.

The Board finds the best evidence of market value to be the board of review's comparables #1 and #2, which sold proximate in time to the assessment date and are similar to the subject in

dwelling size, location, and most features, although these comparables have smaller sites than the subject and one comparable is a much newer home than the subject, suggesting adjustments to these comparables would be needed to make them more equivalent to the subject. These most similar comparables sold for prices of \$665,000 and \$757,500 or \$364.38 and \$426.52 per square foot of living area, including land, respectively. The subject's assessment reflects a market value of \$547,138 or \$319.59 per square foot of living area, including land, which is below the two best comparable sales in this record.

Based on this evidence and after considering appropriate adjustments to the best comparables for differences from the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
