



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Anica Kulacic

The parties of record before the Property Tax Appeal Board are Anica Kulacic, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Hawthorn Woods; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$15,236
IMPR.: \$93,798
TOTAL: \$109,034

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of wood siding exterior construction with 2,222 square feet of living area. The dwelling was built in 2002 and is approximately 22 years old. Features of the home include a basement with finished area, central air conditioning, one fireplace and a garage with 695 square feet of building area. The property has an approximately 7,405 square foot site and is located in Round Lake, Lake Villa Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on five comparable sales located in the same assessment neighborhood code as the subject and within .32 of a mile from the subject property. The comparables have sites that range in size from 7,405 to 10,018 square feet of land area. The comparables are improved with 2-story dwellings of wood frame exterior construction containing 1,920 or 2,500 square feet of living area that range in age from 22 to 24 years old. Each comparable has a basement, central air conditioning and a garage ranging in size from 400 to 600 square feet of building area. Three comparables each have one fireplace. The comparables

sold from March 2022 to July 2023 for prices ranging from \$253,000 to \$350,000 or from \$131.77 to \$145.83 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$109,034. The subject's assessment reflects a market value of \$327,135 or \$147.23 per square foot of living area, land included, when applying the statutory level of assessment of 33.33%.¹

In support of its contention of the correct assessment, the board of review submitted information on three comparable sales. Comparable #3 is the same property as the appellant's comparable #3. The comparables are located in the same assessment neighborhood as the subject and within .28 of a mile from the subject property. The comparables have sites ranging in size from 7,405 to 11,326 square feet of land area. The comparables are improved with 2-story dwellings of wood siding exterior construction containing 1,920 or 2,204 square feet of living area that 22 or 23 years old. Each comparable has a basement, one with finished area, central air conditioning and a garage ranging in size from 400 to 600 square feet of building area. Two comparables each have one fireplace. The comparables sold from July 2023 to August 2024 for prices ranging from \$278,000 to \$358,000 or from \$144.79 to \$184.90 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven comparable sales for the Board's consideration, with one comparable being common to both parties. The Board has given less weight to appellant's comparables #1, #4 and #5 due to their remote sale date occurring in 2022, which is less proximate in time to the January 1, 2024, assessment date given other sales available in the record.

The Board finds the best evidence of market value to be appellant's comparables #2 and #3 along with the board of review comparables, which includes the common comparable. The Board finds that these comparables sold more proximate to the January 1, 2024, assessment date and are more similar to the subject in location, design, age, and relatively similar in dwelling size and some features. These most similar comparables sold from January 2023 to August 2024 for prices ranging from \$278,000 to \$358,000 or from \$134.80 to \$184.90 per square foot of living

As of the development of this Final Administrative decision, the Department of Revenue has not published figures for tax year 2024.

area, including land. The subject's assessment reflects a market value of \$327,135 or \$147.23 per square foot of living area, including land, which falls within the range of the best comparable sales in this record. Based on this record and after considering adjustments to the best comparables for differences when compared to the subject, the Board finds a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
