



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Peter Bahe

The parties of record before the Property Tax Appeal Board are Peter Bahe, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Hawthorn Woods; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$53,202
IMPR.: \$147,988
TOTAL: \$201,190

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of brick exterior construction with 2,314 square feet of living area. The dwelling was constructed in 1974 and is approximately 50 years old. Features of the home include a basement with finished area, central air conditioning, a fireplace and a 491 square foot garage. The property has an approximately 9,520 square foot site and is located in Deerfield, West Deerfield Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on five comparable sales located from 0.07 of a mile to 1.28 miles from the subject property.¹ Three comparables have sites that range in size from 8,773 to 10,010 square feet of land area. The comparables are improved with 2-story dwellings of frame exterior construction ranging in size from 1,925 to 2,712 square feet of living area. The

dwellings range in age from 49 to 67 years old. Each comparable has a basement with “0” finished area, central air conditioning and a garage ranging in size from 312 to 572 square feet of building area. Four dwellings each have one fireplace. The properties sold in May and June 2024 for prices ranging from \$525,000 to \$700,000 or from \$256.26 to \$272.73 per square foot of living area, land included.

The appellant also submitted a brief reiterating various characteristics of the subject and comparable properties. Based on this evidence, the appellant requested the subject’s total assessment be reduced to \$137,284² which reflects a market value of \$411,893 or \$178.00 per square foot of living area, land included, when applying the statutory level of assessment of 33.33%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$201,190. The subject's assessment reflects a market value of \$603,630 or \$260.86 per square foot of living area, land included, when using the statutory level of assessment of 33.33%.³

In support of its contention of the correct assessment the board of review submitted information on three comparable sales located within 0.60 of a mile from the subject property. The comparables have sites that range in size from 10,790 to 12,120 square feet of land area and are improved with 2-story dwellings of brick exterior construction ranging in size from 2,187 to 2,888 square feet of living area. The homes range in age from 47 to 52 years old. Each comparable has a basement, with two having finished area. Each dwelling has central air conditioning, one fireplace and a garage ranging in size from 440 to 594 square feet of building area. The properties sold from March 2022 to August 2023 for prices ranging from \$739,000 to \$850,000 or from \$283.59 to \$337.91 per square foot of living area, land included. Based on this evidence, the board of review requested the subject’s assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales, or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight comparable sales for the Board’s consideration. The Board gives less weight to appellant comparables #2, #3 and #5 which are located less proximate to the

² The appellant’s appeal petition depicts a requested total assessment for the subject property of \$137,284 while the brief states a requested total assessment of \$188,958. Pursuant to section 1910.30(j) of the rules of the Property Tax Appeal Board, the assessment amount depicted on the appeal petition is controlling unless a contesting party submits an “Amended” petition setting forth a different assessment request. 86 Ill. Admin. Code §1910.30(j).

³ Procedural rule Sec. 1910.50(c)(1) provides that in all counties other than Cook, the three-year county wide assessment level as certified by the Department of Revenue will be considered. 86 Ill.Admin.Code Sec. 1910.50(c)(1). Prior to the drafting of this decision, the Department of Revenue has yet to publish figures for tax year 2024.

subject than other properties in the record. The Board gives less weight to board of review comparable #3 which sold in 2022, less proximate in time to the January 1, 2024 assessment date than other properties in the record.

The Board finds the best evidence of market value to be appellant comparables #1 and #4 along with board of review comparables #1 and #2 which are more similar to the subject in location, design and some features. However, these properties present varying degrees of similarity to the subject in age, dwelling size and basement finished area, suggesting adjustments are needed to make these properties more equivalent to the subject. These comparables sold from June 2023 to June 2024 for prices ranging from \$582,500 to \$850,000 or from \$258.11 to \$325.67 per square foot of living area, including land. The subject's assessment reflects a market value of \$603,630 or \$260.86 per square foot of living area, including land, which falls within the range established by the best comparable sales in this record. Therefore, after considering appropriate adjustments to the best comparables for differences from the subject, the Board finds the subject's assessment is justified and a reduction in the subject's assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
