



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Jennifer Grimm

The parties of record before the Property Tax Appeal Board are Jennifer Grimm, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Hawthorn Woods; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$17,337
IMPR.: \$92,563
TOTAL: \$109,900

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of wood frame exterior construction with 2,067 square feet of living area. The dwelling was constructed in 1998 and is 26 years old. Features of the home include a basement with finished area, central air conditioning, a fireplace and a 609 square foot garage.¹ The property has an 11,326 square foot site and is located in Lake Villa, Lake Villa Township, Lake County.

The appellant contends assessment inequity regarding the improvement as the basis of the appeal. In support of this argument the appellant submitted information on nine equity comparables located with the same neighborhood code as the subject. The comparables are improved with 2-story dwellings of wood frame exterior construction ranging in size from 2,060

to 2,162 square feet of living area. The dwellings are 23 to 27 years old. Each comparable has a basement and a garage ranging in size from 440 to 609 square feet of building area. Eight comparables have central air conditioning and four comparables each have a fireplace. The comparables have improvement assessments ranging from \$86,506 to \$90,364 or from \$41.00 to \$43.84 per square foot of living area. Based on this evidence the appellant requested a reduction in the subject's improvement assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$109,900. The subject property has an improvement assessment of \$92,563 or \$44.78 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on three equity comparables with the same neighborhood code as the subject. The comparables are improved with 2-story dwellings of wood siding exterior construction with 2,067 or 2,073 square feet of living area. The dwellings are 23 to 26 years old and have basements with finished area. The comparables each have central air conditioning and a garage with 440 or 609 square feet of building area. Two comparables each have one fireplace. The comparables have improvement assessments ranging from \$93,925 to \$99,483 or from \$45.44 to \$48.13 per square foot of living area. Based on this evidence the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains 12 equity comparables for the Board's consideration that are similar to the subject in location, style, age and dwelling size. The Board gives less weight to the appellant's comparables which lack finished basement area that is a feature of the subject.

The Board finds the best evidence of assessment equity to be the board of review comparables which have finished basement area. These most similar comparables have improvement assessments ranging from \$93,925 to \$99,483 or from \$45.44 to \$48.13 per square foot of living area. The subject's improvement assessment of \$92,563 or \$44.78 per square foot of living area falls below the range established by the best comparables in the record. Based on this evidence, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
