



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Stuart Alpern

The parties of record before the Property Tax Appeal Board are Stuart Alpern, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$11,248
IMPR.: \$42,752
TOTAL: \$54,000

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story, multi-family building of masonry exterior construction with 3,046 square feet of gross building area. The building is approximately 101 years old. Features include a basement, 2 full bathrooms, and a 2-car garage. The property has a 4,999 square foot site and is located in Chicago, Rogers Park Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four comparables located within the subject's assessment neighborhood and from 0.20 to 0.90 of a mile from the

subject.¹ The comparables are improved with class 2-11, 2-story multi-family buildings of masonry exterior construction ranging in size from 2,860 to 3,308 square feet of gross building area. The buildings are from 99 to 103 years old. Each comparable has a basement, 2 full bathrooms, and a 2-car garage. Two comparables have 1 or 2 additional half bathrooms. The comparables have improvement assessments ranging from \$36,378 to \$42,335 or from \$11.73 to \$12.85 per square foot of gross building area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject property of \$54,000. The subject has an improvement assessment of \$42,752 or \$14.04 per square foot of gross building area.

In support of its contention of the correct assessment, the board of review submitted information on four comparables located within the same assessment neighborhood, block and street as the subject.² The comparables are improved with class 2-11, 2-story multi-family buildings of masonry exterior construction ranging in size from 2,668 to 3,318 square feet of gross building area. The buildings are from 100 to 102 years old. Each comparable has a basement, two of which have finished area, 2 or 3 full bathrooms, and either a 2-car, a 2.5-car or a 3-car garage. Two comparables have 1 or 2 additional half bathrooms. The comparables have improvement assessments ranging from \$42,031 to \$49,752 or from \$14.10 to \$15.75 per square foot of gross building area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight suggested comparables for the Board's consideration, which are relatively similar to the subject in design, age, building size and most features. Nevertheless, the Board gives the most weight to the board of review's comparables which are located within the same tax block and street as the subject property, unlike the appellant's comparables which are located in a different tax block and street than the subject. The board of review's comparables have improvement assessments ranging from \$42,031 to \$49,752 or from \$14.10 to \$15.75 per square foot of gross building area. The subject's improvement assessment of \$42,752 or \$14.04 per square foot of gross building area falls within the range established by the best comparables

¹ According to the property Index Numbers (PINs) of the appellant's comparables begin with 11-31-101, 11-31-102, 11-31-114, or 11-31-318, indicating the comparables are located within a different tax block than the subject's PIN that begins with 11-31-115.

² The board of review's comparables and the subject property have PINs that begin with 11-31-115, indicating these properties are all located within the same tax block.

in the record. After considering adjustments to the best comparables for differences when compared to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
