



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board (PTAB) are Richard Graef, the appellant, by attorney Kyle Gordon Kamego, of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, PTAB hereby finds **No Change** in the Cook County Board of Review's assessment of the property is warranted. The correct assessed valuation of the property is:

LAND: \$19,140
IMPR.: \$72,378
TOTAL: \$91,518

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a Cook County Board of Review decision pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) contesting the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 3,275 square feet, two-story frame structure on an 8,700 square feet lot in Evanston of Evanston Township, Cook County. The 116-year-old, class 2-06 residence under the Cook County Real Property Assessment Classification Ordinance contained 2.5 bathrooms, an attached two-car garage, air conditioning, and a full basement.

The appellant based the petition on assessment inequity, contending that the assessment should be lowered to \$20.87 per improvement square foot. As evidence of nonuniformity, the appellant presented four class 2-06 residences within .3 miles of the subject. These suggested comparables featured a one- or two-car garage, one to 3.5 bathrooms, air conditioning, and a full basement. These potential comparators were between 85 and 141 years in building age; 2,812 and 3,372 square feet in improvement size; and \$20.27 and \$21.93 per living square foot in improvement assessment.

The board of review countered that the subject improvement assessment of \$72,378, or \$22.10 per living square foot, was equitable in its “Notes on Appeal.” In defense of the \$91,518 total subject assessment, the county board of review proposed four two-story buildings on the subject’s block as equity comparables. The board of review’s preferred comparators all featured air conditioning, a one- or two-car garage, and a full basement to slab foundation. These properties were 95 to 121 years in building age; 2,586 to 4,169 square feet in living area; and \$23.68 to \$26.02 per living square foot in improvement assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. The Illinois Constitution requires real estate taxes “be levied uniformly by valuation ascertained as the General Assembly shall provide by law.” Ill. Const., art. IX, § 4 (1970); Walsh v. Property Tax Appeal Board, 181 Ill. 2d 228, 234 (1998). Yet this uniformity provision of the Illinois Constitution does not mandate absolute equality in taxation; instead, a reasonable degree of uniformity in the taxing authority’s assessments suffices. Peacock v. Property Tax Appeal Board, 339 Ill. App. 3d 1060, 1070 (4th Dist. 2003).

When the ground for appeal is unequal treatment in the assessment, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e); Walsh, 181 Ill. 2d at 234 (1998). Clear and convincing evidence means more than a preponderance of the evidence, but it does not need to approach the degree of proof required for a criminal conviction. Bazyldo v. Volant, 164 Ill. 2d 207, 213 (1995). Proof of unequal treatment in the assessment should consist of assessment documentation for the year in question of similarly situated properties of compelling proximity to, and with a lack of distinguishing characteristics from, the subject property. 86 Ill.Admin.Code §1910.65(b). The Property Tax Appeal Board (PTAB) finds the appellant fell short of satisfying this burden of proof.

Of the parties’ submissions, board of review comparables #1 and #4 and appellant comparable #3 most resembled the subject property and therefore create the range of equitable assessments for the subject improvement. Board of review comparables #1 and #4 closely tracked the subject’s living square footage, though board of review comparator #4 had a worse basement and garage, while comparator #1 lacked the subject’s half bathroom and some garage space. Appellant comparable #3, on the other hand, mitigated its smaller garage with a larger improvement and extra full bathroom relative to the subject. Given this record, the subject improvement would be equitably assessed from \$20.63 to \$26.02 per living square foot. Because the subject assessment of \$22.10 per improvement square foot is within the range of equitable assessments, PTAB concludes the appellant did not demonstrate inequitable subject assessment by clear and convincing evidence and a reduction commensurate with the appellant’s request is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
