



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Mark Burka, the appellant, by attorney Brian S. Maher, of Weis, DuBrock, Doody & Maher in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$30,938  
**IMPR.:** \$142,063  
**TOTAL:** \$173,001

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a 2-story dwelling of frame and masonry exterior construction with 4,818 square feet of living area. The home is approximately 24 years old. Features include a full basement, central air conditioning, two fireplaces, and a 2-car garage. The property has an 11,250 square foot site and is located in Wilmette, New Trier Township, Cook County. The subject is classified as a class 2-08 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located within the subject's assessment neighborhood code. The comparables are improved with 2-story, class 2-08 dwellings of masonry exterior construction ranging in size from 3,812 to 4,881 square feet of living area. The homes range in age from 39 to 62 years old.

Two comparables each have a full or partial basement and two comparables each have a slab foundation. Three comparables each have central air conditioning. Three comparables each have one or two fireplaces. Each comparable has a 2-car or a 3-car garage. The comparables have improvement assessments ranging from \$55,026 to \$105,762 or from \$11.79 to \$24.19 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$173,001. The subject property has an improvement assessment of \$142,063 or \$29.49 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located within the subject's assessment neighborhood code. The comparables are improved with 2-story, class 2-08 dwellings of frame, masonry, or stucco exterior construction ranging in size from 4,302 to 4,885 square feet of living area. The homes range in age from 3 to 12 years old. Each comparable has a full basement, central air conditioning, and one fireplace. Three comparables each have a 2-car or a 3-car garage. The comparables have improvement assessments ranging from \$136,387 to \$184,565 or from \$30.58 to \$39.02 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

### **Conclusion of Law**

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight suggested equity comparables for the Board's consideration with each having the same assessment neighborhood code, design, and classification as the subject. The parties' comparables have varying degrees of similarity to the subject in age, dwelling size, and other features. Nevertheless, the Board gives less weight to the appellant's comparables #1 and #4 which have slab foundations, in contrast to the subject's full basement, and board of review comparable #3 which lacks a garage amenity, which the subject features. The five remaining comparables, with basement foundations and garages like the subject, have improvement assessments ranging from \$87,676 to \$184,565 or from \$21.67 to \$39.02 per square foot of living area. The subject's improvement assessment of \$142,063 or \$29.49 per square foot of living area falls within the range established by the five remaining equity comparables in this record. After considering the necessary adjustments to the best comparables for differences from the subject, including but not limited to age and dwelling size, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
