



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Rodney Zimmerman, the appellant, by attorney Kyle Gordon Kamego of Robert H. Rosenfeld & Associates, LLC in Northbrook; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$26,320
IMPR.: \$138,054
TOTAL: \$164,374

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2024 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of masonry exterior construction with 4,834 square feet of living area. The dwelling was constructed in 1997 and is approximately 27 years old. Features of the property include a full basement, two fireplaces and a 2.5-car garage. The property has an 18,800 square foot site and is located in Winnetka, New Trier Township, Cook County. The subject is classified as a class 2-08 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables that have the same assessment neighborhood code as the subject and are located from 1.5 to 2.1 miles from the subject property. The comparables are class 2-08 properties improved with two-story dwellings of masonry exterior construction ranging in size from 4,129

to 4,907 square feet of living area. The dwellings range in age from 25 to 60 years old. Each comparable has a full or partial basement, central air conditioning, two fireplaces and either a 3-car or a 3.5-car garage. The comparables have improvement assessments that range from \$105,050 to \$123,906 or from \$23.20 to \$27.25 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$121,382 or \$25.11 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$164,374. The subject property has an improvement assessment of \$138,054 or \$28.56 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables that have the same assessment neighborhood code as the subject and are located approximately $\frac{1}{4}$ of a mile from the subject property or within a subarea of the subject. The comparables are class 2-08 or class 2-09 properties improved with two-story dwellings of masonry exterior construction ranging in size from 4,229 to 5,656 square feet of living area. The dwellings are from 11 to 20 years old. The comparables each have a full basement with finished area, central air conditioning, from two to six fireplaces and either a 2-car or a 3-car garage. The comparables have improvement assessments ranging from \$149,284 to \$250,167 or from \$35.30 to \$45.23 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight comparable properties for the Board's consideration. The Board has given less weight to the appellant's comparables, which are located 1 or more miles from the subject and/or are less similar to the subject dwelling in age than other comparables in the record. The Board has also given less weight to board of review comparables #1 and #4 due to their larger dwelling sizes, when compared to the subject.

The Board finds the best evidence of assessment equity to be board of review comparables #2 and #3, which are located most proximate to the subject and are relatively similar to the subject in dwelling size and design. However, the Board finds these two comparables have varying degrees of similarity when compared to the subject in age, basement finish and other features, suggesting adjustments would be required to make the comparables more equivalent to the subject. Nevertheless, the comparables have improvement assessments of \$149,284 and \$250,167 or \$35.30 and \$45.23 per square foot of living area. The subject's improvement assessment of \$138,054 or \$28.56 per square foot of living area falls below the two best

comparables in the record. After considering adjustments to the best comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
